SYNOPSIS

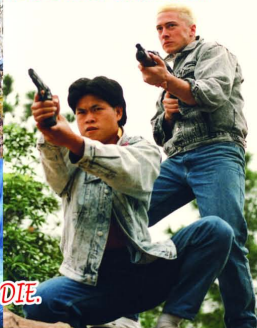
